- a. Strategic Partner Updates: Executive Director (ED) Ericka Summers gave an overview of the Strategic Partners (SP) and their project. Their SPs are 2 ½ years into their 3-year contract with a 2-year extension. ED gave an overview of the 12 SP that the First 5 Yuba currently funds.
- b. 2022 2023 Mini-Grant Updates: Committee members stated that the process was quicker and easier. ED gave an overview of the two types of mini grants that First 5 funds. The ED showed a snapshot of the mini grant applicants that the Advisory Committee approved for larger projects and the smaller mini grants projects that were approved internally this year. The smaller project mini grants were translated this year into Spanish and which in turn allowed the home child care providers an opportunity to answer in their primary language.
